1. Please highlight the **activities/events and/or projects** of your ministry/committee since last year's convention.
  - **Maintain high standards for financial reporting, following GAAP (Generally Accepted Accounting Principles).** Ensure that our finances were audited by an outside agency. The 2019 audit was completed and reviewed by Standing Comm. August 2020. Work with our auditors to ensure we are in compliance with the new accounting standards updates for non-profits (ASU 2016-4) taking effect in 2018 & 2019.
  - **Developed 2021 budget that reflect the Bishop's vision and strategic plan and reflects the reality of the impact due to the Global Pandemic.** Managed, with the Standing Committee, budget changes/recommendations throughout 2019 and 2020. Provide financial relief to congregations by implementing a Congregational Pledge waiver for June – December 2020. Any contribution congregations feel comfortable giving is welcome and greatly appreciated. Our priority is to ensure, during these difficult times, congregations are able to meet their financial responsibilities.
  - **Acted as the Bishop's Staff liaison to various diocesan committees including Standing Committee, Investment Committee, FIT Committee, Convention Budget Committee, etc.** Continued to work with Church Pension Group to ensure our insurance needs are met. Make recommendations to the Investment Committee and the Standing Committee to provide waiver for congregations with outstanding Developmental Loan Fund Loans. A payment moratorium and forgiveness of interest was granted for May – December 2020.
  - **Participate in the ad hoc committee, formed by the Standing Committee at their August 2020 meeting, to implement the action taken to sell the Emmaus Camp property: 3.93 acres.** The Emmaus Camp has not been used for the mission or ministry of the Diocese, Deaneries or Congregations for many years and there are no future plans for the use of this property by the Diocese, Southeast Deanery or St. Andrew's, Petersburg. The decision to sell, although difficult, was made with input from the Southeast Deanery and St. Andrew's Petersburg as the Emmaus Camp is located on Kupreanof Island, across the Wrangell Narrows from Petersburg.
  - **Manage and stay current on the Denominational Health Plan, including the potential impact Patient Protection and Affordable Care Act (ACA) may have.** A copy of said policy can be found on the diocesan web-page.

- Attended the three deanery meetings that have taken place, either virtually or in-person. The Interior Deanery had not yet met at the time this report was written. Assisted congregations with administrative and other issues as they arose and provided support to the Interior Deanery Executive Committee & Arctic Coast Deanery leadership. Provide support and information to congregations, navigating the various programs, grants, relief available due to COVID-19.
- Navigate the various relief programs, grants, and loans available through the CARES ACT and other COVID-19 relief programs and determine which best fits the diocesan needs. Apply for and secure a Paycheck Protection Program Loan for the diocese and assist congregations as needed. Track eligible expenses and keep electronic records and backup documents to maximize our forgiveness; we anticipate 100% forgiveness on the \$88,315 PPP Loan. Stay abreast of all changes to legislation and the impact those changes will have on our participation in programs. This is a daunting task as things are constantly changing as the impact and information relating to the pandemic is consistently changing.
- Continue to provide Human Resource support to the staff and congregations.
- Research and keep current with all State, Local and CDC COVID-19 Health Mandates, Restrictions and Guidelines and ensure we are compliant. Develop and maintain Bishop's Office Mitigation Plan. Work with staff to ensure guidelines and mitigation plans are followed. Follow all Fair Labor Acts related to COVID-19 leave.
- Research and purchase supplies such as CDC approved coronavirus disinfectants, hand sanitizers, PPE (masks & gloves). Shortages due to the pandemic continue, making securing supplies more difficult.
- Assist Bishop Mark in developing Congregational Mitigation Plans and Travel restrictions.
- Continued implementation of the Small Mission Clergy Program. We currently have eight congregations participating. We will continue the program in 2021; funding for the program is included in the 2020 & 2021 Budget.
- Engage with the College of Congregational Development in the Diocese of Olympia to expand partnering in ministry. Due to the pandemic, the 2020 in-person Colleges were cancelled. There have been virtual training opportunities and I have been participating in the monthly trainers Zoom meetings. The plan is to send four congregational teams in 2021.
- Due to COVID-19 we will not be holding in-person training events in 2020. We are exploring online opportunities and plan to continue with in-person training in 2021, once it is deemed safe to have in-person gatherings.
- Continued follow-up with diocesan team (Bishop Mark, The Rev. Luran Pifke, The Rev. Chip Mills, Bob Coghil and myself) that attended Project Resource 2.0, a new stewardship training resource offered through the College for Bishops in 2018. The goal of the training is to help Dioceses and, by extension, individuals within our parishes to grow in their stewardship journey. We continue to meet via teleconference and are working on a plan to share the resources with deaneries, congregations and the diocese. These efforts have been put on hold due to the pandemic.

- Continued work on developing and implementing a diocesan leadership project, as a result of, attended Diocesan Leadership Initiative in 2018. This was a training resource hosted by Episcopal Church Foundation and the College for Bishops. These efforts have been put on hold due to the pandemic.
- Provide administrative and program support for the planning and implementation of Diocesan Convention. The 2020 Diocesan Convention will be "virtual" via a Zoom Meeting and live stream. The planning, coordination and execution of this endeavor is extensive; it has and continues to consume a great deal of time and energy. Coordinate with the IT consultants to ensure that Convention runs smoothly.
- Provide administrative and financial support to congregations as needed, including but not limited to insurance & property matters, financial, budget and accounting matters, employment issues, pastoral needs, etc.
- Work with congregations that have vacant clergy positions and are in various stages of a clergy search process to understand the administrative and financial impacts. Provide support with position listing and advice and counsel to search committees and search committee chairpersons.
- Enroll, learn and utilize tools to adapt to the new virtual reality; including but not limited to Zoom, Microsoft Teams, EZText, Egive, Constant Contact.
- Network with Province 8 Transition Ministers and attend Spring/Fall Zoom meetings.
- Please see the enclosed financial reports, including 2021 Diocesan Budget, Congregational Pledge Reports, Parochial Report Data, and 2019 Financial Section of Delegate Packets

2. Tell us about the **goals** of your ministry for the upcoming year:

My goal is to continue to provide for the administrative needs of the Bishop's Office and diocese. The first priority is to ensure that our finances are recorded accurately and timely and our accounting systems and procedures follow GAAP, Generally Accepted Accounting Principles. Continue to work with the auditors to ensure we will be compliant with the new Non-Profit Accounting Rules (ASU 2016-14). Continue providing congregational development tools with the continued implementation of the Small Mission Clergy Program, the participation of congregational teams to the College for Congregational Development and providing regional licensed ministry training events. Work with the Stewardship team and the Diocesan Leadership Project team to continue to move those efforts forward. Other administrative needs include: insurance, pension, legal issues, property issues, building and ground maintenance, implementation of the Medical Insurance Policy which supports the DHP (Denominational Health Plan) Canon, monitor impact of and ensure compliance with Patient Protection and Affordable Care Act (ACA) on our policies and practices. Support congregational ministry by providing deanery funding to be used at the discretion of each deanery for their congregational ministry development. Provide support to the deanery structures, as requested. Continue to keep current with the legislation, guidelines, health mandates, etc. relating to COVID-19 and measure and adjust to their impact on the Episcopal Diocese of Alaska.

1. Please highlight the **activities/events and/or projects** of your ministry/committee since last year's convention.

The Standing Committee met in person in August, 2019 in Fairbanks, and in November, 2019 in Anchorage. Telephonic meetings were held in February, April and June 2020, and a Zoom meeting was held in August 2020.

Officers elected for the year were the Rev. Caroline Malseed, President; Ms. Peggy Fisher, Vice President; and the Rev. Mary Norton, Secretary.

Among the activities for the year included, but was not limited to:

- Interviewing one candidate for ordination.
- Receiving regular reports from Bishop Lattime and Canon for Finance and Administration, Suzanne Krull.
- Receiving regular reports from the Investment Committee.
- Discussion of development of Diocesan Prison Ministry.
- Discussion of how the Society of St. Simeon and St. Anna should be continued in the future. This question was referred to the deaneries for further input.
- Discussion of the property known as the Emmaus Center on Kupreanof Island, which was given to the Diocese to be used as a camp and conference center. The property has not been used for ministerial purposes, or maintained, in some years. After consultation with the Southeast Deanery, the decision was made to sell the property.
- Accepting recommendation from Bishop Lattime and Diocesan staff that parish pledge payments to the Diocese be waived if congregations experience financial hardship.
- Accepting the annual audit of Diocesan finances.
- Accepting the proposed 2020-2021 Diocesan Budget.
- Accepting the proposed Clergy Compensation Guidelines for 2021.
- Approving a grant to St. James the Fisherman, Kodiak, for assistance with building repairs for an accident that was not eligible for insurance reimbursement.
- Due to COVID-19 concerns, the decision was made to conduct the 2020 Diocesan Convention via Zoom. Diocesan Chancellor Sarah Stanley provided valuable advice to

assure that all business conducted in this manner met the Canons of Episcopal Church and the Diocese. Diocesan staff reported ongoing efforts to enable representatives from communities with limited internet access to participate as fully as possible. The Committee held extensive discussion regarding the manner of registration, submission of nominations and resolutions, election procedures, and other issues regarding facilitation of convention in a new format. Canon Suzanne Krull provided input from other dioceses who are also conducting virtual conventions. The Committee approved the use of consultants to assist with Convention should this be needed to assure an orderly and inclusive Convention.

1. Please highlight the **activities/events and/or projects** of your ministry/committee since last year's convention.

**The Commission On Ministry [COM] is supposed to assist the Bishop in the formation and education for the ministry of all baptized persons.**

This, of course, includes lay and ordained ministries. The COM is guided in its work in the Episcopal Diocese of Alaska through the development of criteria for a process of formation and education that is meaningful, helpful, of service to the Church, and is all of the same to the person in formation so they don't struggle and founder.

The COM met by electronic means each month during the year since the 2019 Convention of the Diocese of Alaska. Bishop Mark Lattime has been an active participant with the COM in carrying out its business.

Sub-groups of the COM worked at identified tasks between meetings, and brought their work back for consideration, guidance, and adoption by the full Commission.

The COM worked with Diocesan staff to provide material for the updated website. This material included forms and guidelines for the Episcopal Diocese of Alaska that have been updated and brought into alignment with the Canons of the Diocese and of The Episcopal Church.

Educational and experiential resources (schools, programs, courses and so on) have been identified and are in development for use within the Diocese. The COM worked to establish additional helps and guidance, in the development of additional documentation.

Clarity has been added to the complicated process of formation for ordination to the diaconate and priesthood through publication of a process and checklist for ordination. The COM developed and is implementing a program of mentoring for those who have formally entered the process.

The COM was directed by the 2019 Convention to intensify efforts to identify, encourage, and assist formation (and, ultimately, ordination for some) spiritual leaders within the Diocese of Alaska, and to report back.

Of course, this cannot be done without dialog with the congregations and their active participation in the process as they assess their gifts and their needs for the nurture of spiritual leadership. We need early identification and encouragement for nominees. We went about this in several ways:

- The COM provided additional information and direct support for the process of discernment of call to several congregations of the Diocese. We developed more information on ways discernment happens in the Diocese of Alaska and are reaching out to make it available. The COM recognized that didn't go far enough. The Rev. Elsa Dehart, and Chancellor Sarah Stanley researched and wrote helpful guidance for this.
- We asked for assistance from those attending the 2019 convention in identifying persons who might be called to a path of ministry. Then its members contacted those persons directly. We now have a little list of people to check in with or leave alone, depending on what we learned.
- We asked for help in reaching those with stand-out ministries in congregations without regular ordained leaders. The Licensed Ministry training developed and led by the Bishop and Diocesan Staff helped in this. This gave us another little list of people to check in with.
- We asked for interest directly. A letter was written and sent out by The Rev. Marilyn Duggar from the COM, to Interior congregations. That has generated some more interest.
- We sought to build community of support for those in the process of formation. The Rev. Dawn Allen Herron is working with those in the metro Anchorage area to initiate regular gatherings and pool resources

as help along the path. Some of these folks are seeking to return to their remote home congregations, in ministry.

2. Tell us about the **goals** of your ministry for the upcoming year:

**There is a LOT going on that is worth continuing and growing.**

We now have five people actively participating in the process of formation for ordination, as Nominees, Postulants, and Candidates. We have identified several who are in discernment, and several actively interested, as well as others who are interested, but have other life-factors (such as family care and health) which must be addressed, first. The COM and its members want to see that the support needed is available for this growth to continue.

We also would like to build on the success of Diocesan programs of education of ministry licenses. The COM wants to make certain that our small congregations can nurture and develop the spiritual resources that are already within them. We want to help create and deploy new courses, and help the congregations to raise up leaders.

We have a lot to learn about sustaining life and walking in the way of Jesus in this stressed and rapidly changing world. The message of the Gospel is here among us, in all of our places. The Commission on ministry is committed to learning how the ministry of all the baptized best lives and serves and thrives among us.

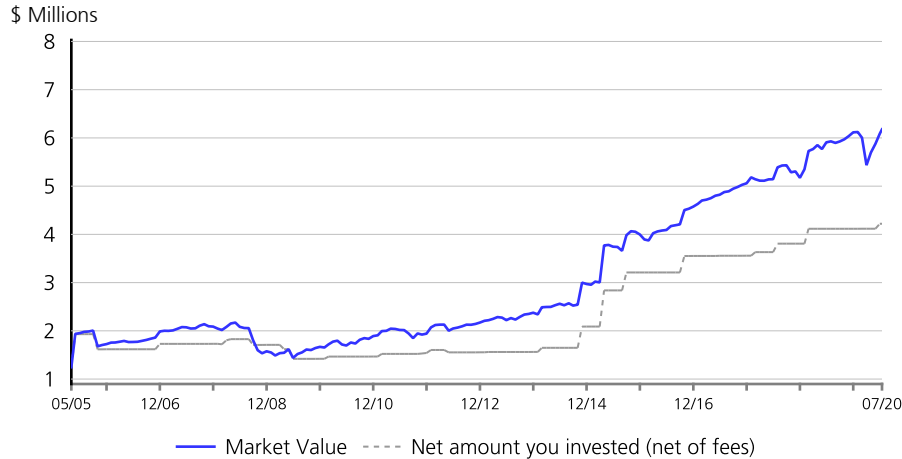

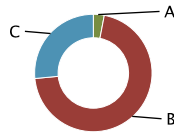

## Ministry Report

Name: Adam Lees - Dean Committee/Deanery/Ministry: Southcentral Deanery

1. Please highlight the **activities/events and/or projects** of your ministry/committee since last year's convention.

The deanery continued to market the mission and ministry grants for congregations and has seen steady increases in congregational use of those funds. With the pandemic's outbreak leading to lockdowns starting in March, the in-person annual meeting to be held in Homer was canceled. We will hold our annual meeting for the first time digitally (via Zoom) on Saturday, September 12 from 1:30-4pm with the assistance of St. Mary's – Anchorage. As of September 8<sup>th</sup>, eight of 14 congregations had registered participants. As always, our goal is 100% participation.

We have consistently noted the inadequacy of our communications infrastructure. With the pandemic making digital communication even more pressing, the executive board organized to reach out to all of our congregations to update all contact information as well as assemble the only comprehensive guidebook of clergy currently serving or otherwise present in Southcentral Alaska. We hope to update these resources annually as well as expand to include the contact information of the primary lay leadership (senior warden/church committee chairs) of each congregation as well.

The final project the deanery undertook this year was financial support to all of our congregations. The Board reached out to all of our congregations and found, overall, that the financial situations of all of our congregations were overall solid if somewhat tight due to revenue shortfalls in several areas. Nonetheless, community and congregational need were expressed. The Board approved unconditional "stimulus" funds from our Diocesan (General) Mission/Ministry reserved funds to send all congregations \$500 to use as they saw fit.

2. Tell us about the **goals** of your ministry for the upcoming year:

The Annual Meeting may yet add to this list, but our main goals for the following year are as follows:

- 1) Maintain our communications lists and continue to improve our infrastructure and address any shortcomings in this area.
- 2) Continue to provide and advertise deanery financial resources, especially for youth.
- 3) Maintain an active and relational deanery executive board, among the officers and between the board and congregations.
- 4) Assess the successes, failures, and opportunities of the digital platforms for future deanery meetings, events, and mission.
- 5) Formulate a guide for the deanery's mission and ministry within the diocese and among our congregations and implement it.

Please explain your overall financial situation:

The deanery continues in a solid financial position. COVID eliminated the most expensive line items in our budget (related to our annual meeting) while assessments were remitted in a timely fashion. Our restricted reserves also remain in good health despite heavier than usual draws to support congregations



during the pandemic. The General Youth Fund balance has grown to \$14,732; Youth Event Fund balance remains \$4,334.67; Youth Camp Scholarships remains \$1,000; and General Mission and Ministry has decreased to \$13,156.62. Much gratitude goes to our outgoing Treasurer, Carol Batson of All Saints' – Anchorage, for her four years of service to the deanery.

4. Please share any other **comments or concerns** that you have regarding your ministry.

In terms of finances, two items stand out:

- 1) The Deanery maintains a very large reserve for youth ministries and we would like to see this used to organize youth ministry, particularly by congregations who may not have a critical mass for a sustainable youth program. St. Mary's approached the deanery for funds to subsidize youth participation in the triennial Episcopal Youth Event. Sadly, COVID caused the event to be canceled for the time being. We hope more congregations will be intentional about connecting their youth to the larger church and taking advantage of deanery opportunities so to do.
- 2) Deanery Mission and Ministry Grants, from funds allocated by the diocese, remain available. The Executive Board has made it a general policy to cap these at \$500/grant/congregation/year; however, **this limit can be waived given the right circumstances.**

Per the Bishop's address and presentation at our 2019 annual meeting, the deanery is considering organizing a small endowment from both general and restricted funds in our accounts. We would love assistance from the diocese in this process.

In general, the deanery as an institution is rather weak. Communications issues centered around technology, lack of an independent/up-to-date presence, list maintenance (including data and privacy protection), and regular updates of information will require further work. Our bylaws have also proven overly sparse for some situations while many policies and tasks remain rather ad hoc. We also tend to borrow digital resources. While this saves funds and has generally worked well, it does leave us exceedingly vulnerable to unforeseen circumstances.

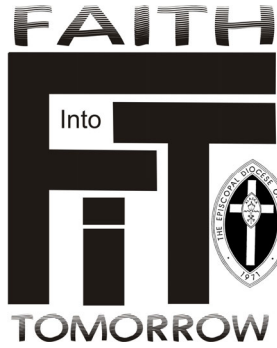

## FAITH INTO TOMORROW – GOOD NEWS ENDOWMENT 2020 ANNUAL REPORT

The **Faith Into Tomorrow – Good News Endowment** is a diocesan endowment fund conceived around 1992 by Bishop Charleston and other diocesan leaders. The **FIT Campaign**, conducted during 1993, appealed to Episcopalians across the state to pledge towards the vision of Bishop Charleston, to establish a fund that would concentrate our efforts towards six specific ministries. The Diocesan Investment Committee oversees the ongoing management of the investment of the endowment funds. The FIT Oversight Committee oversees the distribution of the interest from these funds through grants and operating budget line item funding.

**Membership:** The FIT Oversight Committee (OC) consists of eight persons. Two laypersons and two clergy will be elected by the Convention. The Bishop, on recommendation by the FIT OC Chairman, will appoint three at-large members. The Diocesan Canon for Finance and Administration will be an ex-officio member. The elected and appointed members serve 4-year terms.

The current members of the committee are: Ron Moore, Chair (Appointed, Fairbanks); The Rev. Wilson Valentine, (Elected Clergy; Juneau), The Rev. Mary Norton, (Appointed; Kotzebue); Bella Schjenken (Elected Lay, Anchorage); Alice Holinger (Appointed; Wasilla) , Maggie McKay (Elected Lay, Anchorage) , The Rev. Julie Platson (Elected Clergy; Sitka), and ex officio Suzanne Krull (Staff Liaison).

The committee held four meetings in 2020 by audio-conference. A Zoom meeting is scheduled for early November 2020.

- 1) What work was done? *Following a previously undetected leak in April 2020 from the Rectory fuel oil tank, approximately 290 gallons of fuel oil leaked into the public waste-water disposal system of Kodiak. Because the State of Alaska became involved as the spill was in violation of environmental regulations, St. James was required to submit a mitigation plan to the State for approval which was done. The mitigation work has been completed and paid for. Most of the expense related to the clean-up has been incurred already except for that involved in monitoring the contaminated soil for the next several years.*
- 2) How was the money spent? *To date, St. James has paid a little over \$30,000 on the clean-up and related costs (see attached accounting).*
- 3) Suggestions for improving the grant/loan process: *The process was by all accounts simple and efficient once the data supporting the application was gathered and passed on to the FIT Committee*

Since this has arrived, the pastor and Sunday School classes have incorporated sharing stories from the Godly Play curriculum in Zoom worship (children's sermons and Sunday School), confirmation, and videos for youth.
- 2) How did your program impact your youth? Your youth ministry?  
The profound wisdom of this Godly Play curriculum is very easy to see with even just the first use of it in a children's sermon. For instance, a youth who does not particularly engage in children's sermons often was very open about what he wondered about in a story and shared some insights about his faith that he had not previously shared.

This serves as a tool for all educators in our church and can be a way for youth to engage in visual ways, which is greatly appreciated in this time of pandemic and interacting with youth in virtual space is especially difficult and lacking in authenticity. We are very grateful that we had this grant to be able to order this as it is very useful right now!

This engages youth to explore their own relationship with God, remind people that they all have important thoughts about God, and to understand stories about God in a fresh and renewing way.

## **Cudd Hall Community Kitchen**

### **St. George's-in-the-Arctic, Kotzebue**

The Cudd Hall Community Kitchen is a program that was started a number of years ago to provide a Sunday afternoon meal for the homeless, needy, elderly, or other folks in Kotzebue. Always staffed by volunteers and relying on donations, it expanded to include lunches two days per week. We stopped earlier this year for about a month, due to Covid-19 restrictions on indoor gatherings, but the need was still apparent. Representatives of several other organizations in town got together to secure funding for weekday meals, which church members and others have helped prepare and distribute on a take-out basis from Cudd Hall. We restarted the Sunday meals, also handed out at the door now: not quite as elaborate nor much opportunity to socialize, but still much appreciated and a blessing to both givers and receivers.

The program has impacted our community in many ways, beyond the individuals served food. This year, our records of how many people we have served have guided organizations and individuals who are looking at ways to help the homeless and others who are adversely impacted by Covid-19. We are seen as a center for providing such help, and we have been able to provide the facility for others joining in the efforts. Prior to the gathering restrictions, we were also often the location for Search and Rescue support, funeral potlucks, rummage give-aways, and other community gatherings. Although our congregation is small in number, this program has been a great outreach and it is a blessing to be able to continue, especially in these unusual times.

We are called to take care of the poor, the widowed, the orphaned, the lonely, those on the edge. We see God's work in the Cudd Hall Community Kitchen as we not only feed bodies but provide comfort and build relationships, especially in these times when people may feel cut off from one another. Being able to continue this program seems at least as important as broadcasting or holding in-person worship services.

The FIT grant funds have been spent on supplies for the meals, such as serving containers and non-perishable items that we have shipped in bulk from Anchorage or Amazon, and perishable items like fresh vegetables, bread, and sometimes meats, purchased here. We are thankful to have received many donations: locally caught meat and fish; items reaching "sell by" dates at the local stores; goods brought by organizations and individuals, and even mailed to us from as far away as Virginia! Like a stone thrown into a pond, the ripples reach far.

Many thanks to Brad and Mary Reeve and Ella Lisbourne for applying for the FIT grant, and Brad and Mary for taking care of most out-of-town purchases; to Blaine Barger and the volunteers who have worked with him for cooking delicious food and keeping the program going; to Alaska Airlines, City of Kotzebue, NIHA, NWABSD, Maniilaq Association, NMS, AC Store, Northstar Market, KEA, and the many individuals who have donated food, supplies, funds, and time to keep the Cudd Hall Community Kitchen operating and serving our region; and most of all, thanks and praise for God's help and blessing in it all.

We wanted to thank the Faith Into Tomorrow Endowment for awarding us a \$2500 grant. St. Christopher's Food Pantry is a much-needed resource that depends on the contributions and assistance of many people in the church and community.

The following statistics reflect people served from January 2020 through August 31, 2020, the total expenditure for food was \$4847.00, and \$2500.00 was from the FIT grant. There were 753 families, 1628 adults and 753 children, a total of 2381 people served. There were 86 Veterans, 122 disabled and 52 people receiving food stamps. Even though there were more people served this year fewer people received food stamps. Most of the people served at our Food Pantry received referrals from the Job Service and other social service agencies until March when the corona virus struck. Many people could not access referral agencies. We continue to serve everyone who comes to our Pantry even if they do not have a referral. People who arrive at our doors have often exhausted funds they received from other agencies. Since March, many new patrons have come to the pantry because they have lost their jobs, or have applied for assistance and are in a waiting period. Many are faced with the decision of paying their rent or buying food. We also serve the working poor who do not have enough resources to carry them through the month. Some people are homeless and have no resources. We never turn anyone away.

We give any extra produce to the Rescue Mission and to Feeding Our Elders, a non-profit group that provides meals to Alaska Native Elders.

We continue to receive food donations from our parishioners as well as Christ Church Episcopal. Christ Church Episcopal also donates fresh vegetables from their garden during the summer. Rev. Gail Loken brings the vegetables from Christ Church... Ken Popp, a Christ Church parishioner, supplies us with bread, beans and rice as well as the "blessed" food items from Christ Church. We are blessed with many people helping to keep our Pantry open and serving community members in need. Some of our patrons donate plastic bags, egg cartons and other items. They offer to help in any way they can and are so appreciative of what we can give them. They also help each other by sharing rides and telling others where they can get help. We refer our customers to other agencies such as treatment centers, women's shelters and other social service agencies. Our patrons often ask for prayers so we add their request to our prayer list. They also pray for us when we have suffered loss. We are blessed to be able to serve our patrons and to help in our small way to make positive difference in the lives of those who have so little.

Dear F.I.T. Committee,

The Church of the Holy Trinity gratefully received a grant to help initiate a series of short seminars in spiritual development. Specifically, we received \$1,500 from the Faith into Tomorrow Endowment toward a total project budget of \$8,910. Currently we have raised a total of \$6,050 in cash, including the FIT Grant. The remainder of the project budget was to be in-kind lodging and other locally sourced support for the event and was committed towards that goal. Originally, we had in mind a gathering around Bishop Steven Charleston in discussion of his book *The Four Vision Quests of Jesus*. We had begun to assemble an advisory body for planning, scheduling, and arranging this, when we were overtaken by the pandemic.

Covid-19 has led us to suspend planning for the event, hoping that we could return to our original plans within a short time. It is now clear to us that optimism alone cannot serve as a plan. This current epidemic will prevent a return to normal operations within the foreseeable future. However, we have been watching as more technologically advanced organizations have found ways to host gatherings, develop meetings and seminars, and even produce national political conventions using technology in place of in-person gatherings.

We ask that you grant us more time to develop our plans in a new direction using technology to host the seminars that we originally envisioned as in-person meetings. With the concurrence of the Archdiocese and the Faith into Tomorrow Endowment, we will continue to hold the funds received in a designated account, until such time as the event may be brought back into planning and development.

## DANCING WITH THE SPIRIT ACCOMPLISHMENTS 2020

Dancing with the Spirit is a program that teaches guitar, fiddle, mandolin, ukulele, singing, and dancing to students in villages—operating out of the Episcopal Diocese of Alaska office. It is funded by schools, tribal councils, and individual contributions. We have an 11 member Board of Directors and elected officers who guide the program and have developed our mission statement. “Dancing with the Spirit connects youth and elders through school music programs and camps--promoting spiritual, physical, and mental wellness with the joy, love and hope of music. Our goal is to prevent suicide, drug, alcohol, and domestic abuse by building self-esteem, preserving musical traditions, and encouraging strong healthy communities.”

1. Over the past fourteen years, we have traveled to 55 villages--plus reached out to the Native communities in Fairbanks, Juneau, Kodiak, Cordova, and Anchorage with music camps. Villages are Alaganuk, Allakaket, Angoon, Anvik, Arctic Village, Beaver, Chalkyitsik, Chenega, Circle, Coffman Cove, Eagle, Emmonak, Fort Yukon, Galena, Grayling, Hollis, Holycross, Hooper Bay, Hughes, Huslia, Hydaburg, Hyder, Kaltag, Kasaan, Kivalina, Kokohanok, Kotzebue, Koyukuk, McGrath, Manley Hot Springs, Mentasta Lake, Minto, Naukati, Nikolai, Northway, Nuiqsut, Nulato, Pelican, Point Hope, Port Alexander, Rampart, Ruby, Scammon Bay, Shageluk, Stevens Village, Tanacross, Tanana, Tetlin, Thorne Bay, Tok, Tyonek, Unalakleet, Venetie, Whale Pass, and Yakutat.
2. These past two and a half years (pre-pandemic), we spent 92 weeks in village school music camps—and in the summers (pre-pandemic) we helped teach and sign up Native students and counselors for the Fairbanks Bluegrass Camp for Kids; taught at the Cordova 4H Music Camp—and led the Southeast Deanery Music Camp in Juneau at St. Brendan’s.
3. Involved 45 part-time staff members in teaching for our school music camps.
4. Received \$35,000 in TCC 2020 Wellness Funds that was used to help Dancing with the Spirit travel spending 11 weeks in TCC villages pre-pandemic—and then received permission to use the remaining funds for our distance music program.
5. Obtained \$5000 in Doyon Daaga’ funding for a Gwich’in Dance Curriculum which will be available later this fall. In addition to filming dancing in Venetie, Fort Yukon, and Arctic Village—we filmed songs for a Gwich’in Christmas Carol Curriculum.
6. Continued to give out a two CD set *Rev. Trimble Gilbert Sings Takudh Hymns*--plus an all Gwich’in CD recorded by Beaver students.

7. Continued work on the Dancing with the Spirit Songbook and Fiddle Tab Book; a Gwichin' Conversation/Songs CD; and a Gospel Guitar Songbook/Play Along CD
8. Received a \$4200 St. Matthews Endowment Fund grant in 2019 for a Minto Music Camp that we used for Distance Music Curriculum due to the pandemic—and \$4200 St. Matthews Endowment Fund Grant in 2020 for Distance Music Curriculum.
9. Received a \$64,450 RurAL CAP Foundation grant primarily for instruments for the villages, plus more song videos, music curriculum, staff connections with the villages, and DVD's and jump drives for villages without high speed internet.
10. Updated our Dancing with the Spirit website with more pictures and information.
11. Sent some of our Dancing with the Spirit song videos to the Canadian Gospel Jamboree.
12. Applied for 3 additional grants for Distance Music Curriculum and village connections.
