



If offered, would you stay in a private home during convention? $\overline{11}$ (i)



Or just plan to have the convention in Anchorage and seek out the best deal for lodging/food and travel. no matter travel it seems to be expensive especailly from smaller communities. Anch. is nice as there may be families the delegates would be able to stay with. someone always knows someone in Anchorage. ??

Doing Zoom for every other convention could work. Maybe that would increase participation by some congregations for Zoom conventions and others for in person ones.

A zoom link would be helpful for people who cannot travel or cannot afford travel, zoom attendees would not have voice or vote. It is expensive for delegates to travel and stay in a hotel, so delegate numbers could be limited. I would suggest one delegate for small congregations (under 100 per annual report) and two delegates for larger. In order to make the convention available to more people, it would be live streamed via zoom or other media to those not attending in person. People attending on zoom could contact their in-person delegate by text or email to express their preference on any issue.

Is there the possibility of the diocese investing in a retreat center that could earn the diocese income the rest of the year?

I have hospitality or safety concerns related to our lgbtqa+ non-binary delegates.

Have the convention in the same urban city every year. Hotels/could be arranged in advance for the same week, reducing rates for rooms. Participants from rural areas would become familiar with the city, transportation, restaurants, church location - perhaps class confusion for participants.

It wiould be helpful to have individual facilitators for small group/breakout sessions/discussions.

It seems like a bit of a vacation for attendees, and they don't return with much for the rest of us. Just glowing reports of how wonderful it all was.

alternating online and in person or having hybrid events are some ways to meet

It is a mistake and a misunderstanding to think that the primary reasons for housing individual homes and earlier years was budgetary. The primary assumption was it was a gathering of the family, a coming together of the people of the church throughout the state. Budgetary concerns were secondary if at all. The emphasis was on the need and call of the people of the church to come together as one. It is a very large state from point hope to Ketchikan, and very different. How can we be the body of Christ, who is not divided, if we do not come together as one? In those earlier days, any hotel expenses were met by the individuals. Meeting and hosting someone from a completely other end of the state was part of the grace of the moment; and the logistical burden of that, and it's accompanying Grace, was part of the task and gift of servanthood the host Church assumed.

Why isn't this a zoom session? Costs could be used to send priest to the smaller communities and also host Bible study for younger kids in communities that never see clergy come in. Easter and Christmas try to have a priest in every church and send Bible study for young children and adults.

Please don't abandon all in-person meetings of Diocesan Convention.

You may not want to include my opinions in your summary as I am retired and am not a voting member of Convention.

Bring everybody into Fairbanks, Anchorage (a hub) and use the church as a meeting place for zoom. Do a Church service prayer separately. Video/classes and speakers can be included in the zoom

I think there is nothing better than face to face contact among delegates and other church leaders. The only downside is cost and the sometimes difficulty of younger church members serving as delegates because i need to take time off from work for 2-3 days.

Conventions in major travel hubs only; Anchorage, Fairbanks, Juneau. Multiple sources of housing & services available.

After listening to the many voices providing feedback at the 2023 convention, what I heard was the "business" of the Diocese has moved beyond resolutions, voting, and budgets. What I heard was a deep cry for feeding of the souls of the diocese through fellowship, prayer, Eucharist, training, and centering our lives in the bodily resurrection of Jesus of Nazareth. Perhaps the "business" of the church is investing in people, and then letting those people live the life of the two resolutions approved.

I would like to see opportunities to engage deeply in small groups following presentations from the Bishop and other speakers--perhaps with a task to accomplish. The idea of a family reunion is fine, but I also think convention should include many new faces as well, especially if we want the energy of Convention to spread more widely into the daily lives of our congregations. (I realize that the responsibility for making this happen lies with the leadership and members of each of our congregations as they are electing their delegates) I think that electronic meetings are fine for dispensing information and carrying out some business functions, but they do very little for building the sense that together we are the body of Christ. The many side conversations that happen in person, or over a meal, or simply having a shared experience (like climbing the Juneau hills) are not easy to replicate in an online format.

We just spent \$60,000 to approve two resolutions, elect three non contested positions, Pat ourselves on the back and say "we've done the work of the Church"

The Bishop has laid the ground work for fresh thinking. A new garden in old soil. That means pulling out what was planted and replacing with something new. It means fertilizing the soil. Tilling the ground. Isn't it time to give 2023 responses to 2023 complex and complicated matters? As opposed to answering 2023 questions with an out of date way and reason for meeting? "Business" is not the work of the Church.

Excerpt from 2023 Convention Minutes: Discussion on Future Conventions.

Rev. Lauran Pifke and Rev. Betty Glover led discussion regarding the Survey for Future Diocesan conventions:

Fred Hanson, Holy Spirit, Eagle River asked about the financial goal of conventions. Rev. Betty Glover explained there is not a goal to make money but the reserve fund that amounted during Covid was depleting and a deficit could not continue.

Todd Mashlan, St. Peter's, Seward, asked why a full-hybrid meeting was not an option. Suzanne Krull explained the equipment is not available and the cost is more than in person.

Barbara Learmonth, St. Brendan's, Juneau, commented on a modified agenda for online zoom.

Loren Hill referenced speakers and tools to bring back to congregations offered at the 2023 South Central Deanery Convention and suggested diocesan convention be modeled similarly.

Jan Hotze suggested an option for meeting in person every 3 years for an extra day for community building with the interim years online.

Fred Hanson suggested an initial set cost covered by the diocese and the remaining cost be covered by the church to put the responsibility on the church to raise money for convention.

Mary Edwin Moses, St. James, Tanana, shared the technological issues for Tanana and surrounding villages to be able to participate in online gatherings.

Israel Portilla Gomez suggested the diocese work harder to gather and not search for an easy solution.

Emily Nenon, St. Mary's, Anchorage, encouraged Standing Committee to draw from experience of laity in the room who holds Zoom meetings in their professional contexts when considering how to hold future Zoom Diocesan Conventions.

Mary Jane Derendoff spoke for native people who weren't raised with computers and the difficulties in navigating online meetings.

Sterling Camden, St. Peters-by-the-Sea, Sitka, expressed the importance of building connections with people in other churches and the deficit that takes place with this during Zoom meetings because only one person can speak at time. He desires to meet in person always.

Catherine Knott, St. Augustine's, Homer, supports in person conventions specifically for indigenous peoples who must be returned to leadership positions and whose inclusivity is of importance and drew attention to the technological difficulties present in many villages.

Daisy Davenport, St. Brendan's, Juneau asked about cost difference between hybrid conventions and alternating online and in-person conventions every other year.

Anne Flint, St. Augustine's, Homer, spoke in favor of in person meetings based on her personal experience of online and in present diocesan conventions. She spoke about people being comfortable sharing things with each other in person that they would not share on Zoom.

Adam Lees, St. Mary's, Anchorage spoke in favor of in person meetings based on his previous personal experience as Dean of South Central.

Ross McKay, St. Mary's, Anchorage, drew attention to those who are not currently present and the exclusivity of this conversation as of hearing their reasonings for being unable to attend during this conversation.

Rev. Dawn Allen-Herron, St. Andrew's, Petersburg, highlighted the importance of being expansive to all levels of ability and her support for hybrid meetings.

Rev. Theresa Thomas, St. Jude's, North Pole, highlighted the importance of being a eucharistic church and being together physically.

Maggie McKay, St. Mary's, Anchorage, suggested the possibility of meeting as deaneries while zooming into together as a diocese and to stress the importance of human connection rather than business in meetings.

Rev. Marilyn Duggar, St. Mark's, Nenana, expressed the stress of the cost and affordability of traveling to in person conventions.

Barbara Learmonth, St. Brendan's, Juneau, expressed the importance of communities considering arranging priorities to provide a larger pledge to support the diocese.

Debbie Tritt-Kendi, Bishop Rowe Chapel, Arctic Village, reflected on past conventions that were more lively and her desire to return to them and asked about the possibility of meeting every other year.

Lisa Terwilliger, All Saint's, Anchorage asked about the possibilities of congregations having their members sponsor various needs of conventions through their vocational work.

Rev. Susan Mitchell, St. John's, Eagle, expressed her support of online conventions for the remote village of Eagle because of inabilities to travel.
